Job Summary:

Providing speech-language services to a pediatric population using a family-centred service delivery model in conjunction with the other members of the intervention team. You will be working with children age 0 – kindergarten entry, doing consultations, assessments, and intervention. Intervention takes place on site, but can also occur virtually, in daycare, preschool or in the family's home.
