Providing speech-language services to a pediatric population using a family-centred service delivery model in conjunction with the other members of the intervention team. You will be working with children age 0 – kindergarten entry, doing consultations, assessments, and intervention. Intervention takes place at either our Surrey or our Langley site, but can also occur virtually, in daycare, preschool or in the family's home.
