Job Summary:

Providing speech-language services to a pediatric population using a family-centred service delivery model in conjunction with the other members of the intervention team. You will be working with children age 0 – kindergarten entry, doing consultations, assessments, and intervention. The Centre for Child Development services families living in Surrey, Delta, Langley, and White Rock. Intervention takes place at either our Surrey or our Langley site, but can also occur virtually, in daycare, preschool or in the family's home. Currently this position will be assigned to our Langley location.

- Masters' Degree in Speech-Language Pathology (or equivalent)
- Registration with the College of Health and Care Professionals of BC
- 1 – 3 years recent clinical paediatric experience is preferred but new grads welcome
